The structure of the article is adequate and its reading is coherent. However, the use of periods instead of commas in numbers with decimals should be standardized. For example, in Table 2 the numbers are presented inappropriately.

Comments to the Author(s): Technical Review

The article is interesting because it presents a specific situation (Indonesia, food industry and "government programs"). However, it is imperative to explain what government programs consist of. Concluding that product or process innovation improves the competitive situation of companies seems obvious, but it would be more appropriate to speak of innovation as a value proposition and point out the effect observed on the competitive position of the company.
